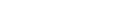

Dear Shorthorn Breeders,

We are excited to announce the 2024 Eastern Ohio Shorthorn Assn. sale on *Saturday, October 5, 2024*, at the Tuscarawas County Fair Grounds in Dover, Ohio. Cronebaugh Auctions LTD will be the managers of this year's sale; we are excited to see the growth of this sale over the past couple of years and hope to continue to grow it for the EOSA Members.

The show will begin at 1:00 p.m. followed by the sale at 3:00 p.m. Cattle must be in place by Saturday, October 5 at 9:30 a.m.; weigh in will be 9:30 – 10:00 a.m. The Fall Sale will include a show to determine the sale order on steer prospects, heifer prospects and bred heifers. Purebreds will sell prior to ShorthornPlus. Sale order for bred cows and bulls will be set by the sale manager.

Purebred and ShorthornPlus cattle eligible for consignment in the Fall Sale include:

- Bred heifers born after August 31, 2022
- Show heifer prospects born after August 31, 2023
- Show steer prospects born after December 31, 2023
- Bred cows born after August 31, 2019
- Bulls born after August 31, 2022

Enclosed you will find a consignment form detailing the information required for entry. All entries must include the non-refundable \$100 per head consignment deposit (to be deducted from your sale expenses).

Sale Regulations as set by the Eastern Ohio Shorthorn Association:

- 1. Individual Health Certificates in compliance with the health requirements of the State of Ohio <u>MUST</u> accompany each consignment on sale day.
- 2. All consignments must sell under the Standard Breeding Guarantee as endorsed by the American Shorthorn Association.
- 3. Heifer entries age 12 months and under must be open. Bred females must be pregnancy checked by a licensed veterinarian 30 days prior to sale day and stated on the Health Certificate.
- 4. ShorthornPlus (1/4 blood to 7/8 blood Shorthorn) cattle must be registered with the American Shorthorn Association. (Please note that ShorthornPlus animals must be 50% Shorthorn blood concentration or higher to be eligible to show at a sanctioned ASA show.)
- 5. All consignments must have legible tattoos which match registration certificates.
- 6. All consignments must be halter broke and exhibited in a professional manner. No bedding will be furnished. (Please do not use any of the surrounding buildings on the fairgrounds as tie outs.)
- 7. Substitutions are permitted; however, consignor is responsible for providing supplemental sheets unless substituted before catalog is printed.
- 8. Late entries may be accepted but must include a \$50.00 late fee in addition to the \$100.00 entry deposit. (Late entries will not be printed in sale catalog but may have supplemental sheets available on sale day).
- 9. All consignors must join the Eastern Ohio Shorthorn Association (Annual Membership Dues -- \$25.00).
- 10. Beef Check Off fee of \$2/head will be deducted from your payment.
